## **Disc Golf Course Rules & Guest Waiver©**

The Flat Creek Estate Disc Course is set amongst the vineyards and serene Tuscan beauty of an 80 acre Estate in the Texas Hill Country. The 18 hole course was designed by John Houck, two time World Champion in Freestyle Frisbee and Disc Golf Hall of Fame Inductee, is renowned as the world's premiere Disc Golf Designer. Flat Creek Estate is located 45 minutes north west of Austin, Texas off FM 1431. John says, "The Flat Creek course is a world class course and the first of a kind designed around a Texas Vineyard."

The development of the vineyard and winery has been a labor of love over 20 years for the owners, Rick & Madelyn Naber. It has become a destination location in the Texas Hill Country featuring many award winning Italian Varietal wines, high end Bistro, 10,000 case winery and tasting room. Madelyn says "The addition of the Disc Golf Course adds a new dimension to your experience at our Estate and another reason to visit and have fun."

All players are considered as guests of Flat Creek Estate. Please join us by respecting and preserving the environment and facilities of this crown jewel in the Texas Hill Country. Flat Creek Estate is an "Agritourism Destination.

### **Course Rules**

- 1.0 All players must check in at the Pro Shop (Troopers Den), complete a waiver and get a wrist band. Those who have not completed a waiver will be asked to leave.
- 2.0 Reservations get first priority on the course.
- 3.0 Players shall only park in the designated Disc Golf parking area.
- 4.0 Removing or damaging trees, plants, turf, grapevines, or other resources is prohibited.
- 5.0 Littering or dumping of waste on the Estate is prohibited. Please use designated litter containers.
- 6.0 Vandalizing or defacing any structure, vineyard, facility or natural feature is prohibited.
- 7.0 Indecent or abusive language or any activity that creates a public nuisance is prohibited.
- 8.0 Firearms, bows and arrows, hunting, trapping or in any way disturbing wildlife is prohibited
- 9.0 Fishing, swimming and Disc diving are prohibited.
- 10.0 No alcoholic beverages are allowed on the course except for wine purchased in our tasting room.
- 11.0 The use or sale of illegal drugs is prohibited on the property.
- 12.0 Pets are allowed on the grounds if accompanied by a registered guest and on lead.
- 13.0 No fires are allowed on the course.
- 14.0 No camping is allowed on the course. If lodging is required, please inquire at the Pro Shop.
- 15.0 Solicitation for business, distribution of flyers or handbills or conducting business is only allowed with written permission of Flat Creek Estate.
- 16.0 Any guest deemed by our staff to display offensive conduct or dress may be asked to leave.
- 17.0 Green Fees are \$20.00 per person. \$15.00 for PDGA members.
